Devon County Council (DCC): key issues

Full Council 22.02.25 To approve the annual county budget 2025/26. Despite DCC and Torbay having formed a combined authority (formalised on 05.02.25), this budget was for DCC only. It was agreed to raise the DCC element of the precept by 4.99%.

The Target Budgets for services reflect an estimated inflationary pressure of £17.7 million due to National Living Wage impacts.

The cost of inflation places sustained financial pressures both on our households and communities, and our suppliers and service providers, contributes to the ongoing impact in terms of price and demand pressures on the Authority's budget. This is reflected in the proposed Target Budgets with total investment of £31.9 million to cover inflation and national living wage plus £33.8 million to cover demand and other spending pressures and priorities. To enable the authority to set a balanced budget, savings, alternative funding and additional income of £21.7 million have been identified.

It is not currently planned to support the proposed budget targets by using general reserve balances. This reflects a strategy of 'living within our means' and as such to set service budgets that are affordable within anticipated income and funding totals for next year.

The targets set for each service area have been subject to different pressures and influences. The table below shows the 2025/26 Budget Targets by service area.

The only amendment proposed to this year's budget was my own to reinstate the Members Localities annual grant fund back to £8,000 rather than the reduction to £5,000 in the draft proposals. This required £180,000

to be drawn from elsewhere in the budget, which I proposed would be taken from the unallocated community fund (which organisations can bid into and is generally approved by officers rather than Councillors). This was approved at Full Council with strong cross-party support.

Devolution & Local Government Reorganisation (LGR). DCC Members Day 25.02.25

County Councillors together with CEO Donna Mason, Directors of Services and senior officers were brought together to provide information and a background and forum for discussion about the Government's request for bids for Local Government Reorganisation. Devon County Council together with Leaders of Torbay Council and Plymouth City Council are working together to explore the creation of a Mayoral Strategic Authority. They are also meeting with leaders from the seven district Councils across Devon to consider the various options f unitary authorities within that larger strategic authority.

A number of options for possible unitary authorities across the county are being looked at by various councils. Devon County Council is working on the premise of have some possible options on the table and ready for the new incoming Council in May, based on discussions over the next few weeks that will prepare for provision responses to government by the 21st March initial deadline.

Three presentations provided at this event that interested me in particular were from the Directors of services for Children's Services, Adult and Social Care and Financial services. Between them they narrated the case for the 80% of DCC's total annual budget that is spent on Childrens Services and Adult social health care. The Director of finances then said that if an enlarged single unitary across Devon was formed and aggregated these two service areas across that area, the savings / efficiencies would amount to £100M p.a. If however, these DCC services were to be disaggregated across a number of new smaller unitary authorities, the cost of disaggregation could amount to at least £111M.

A further element being discussed is the **new public elected representation for the new local Unitary authorities** and how this should be decided. The Boundary Commission is unlikely to be making recommendations due to the sheer number of local authorities involved in this reshuffle. The ratio of electorate to public representative is part of this, plus a decision on how the Wards, divisions etc could be reset. Concerns have been raised about the possible impact of confusion for the public if representation boundaries are substantially changed.

The Governance group that I sit on is currently meeting weekly to shape up the options and the associated potential costs and benefits. I will report further as this proceeds.

20's Plenty – New 20mph routes in Totnes proposed to fill in current 30mph gaps. I have met with officers to consider their proposals. The draft document has been discussed with the Totnes & District Traffic & Transport 20's plenty working group and the map with proposals will be brought to the Town Council at FC meeting this week. Once approved and then agreed with the officers this will then go out to public consultation across the town for final agreement. It looks very positive!

Totnes – Littlehempston All Access Path. A lot of work has taken place behind the scenes to make progress with this route. There is a very proactive local group leader for this work and in just this last 2 months a number of meetings have taken place including DCC officers. I raised this at a key scrutiny meeting in January that led to my hosting a meeting with the LCWIP officers at DCC that has engaged their support and the DCC Cabinet portfolio holder Cllr Stuart Hughes. Cllr Hughes has now requested that this route is added to the formal DCC LCWIP list for approval at next week's cabinet and thereby provide improved status that it is hoped will benefit the position with SWW in their current planning application for a solar array that shares the same location. The route will also be discussed at this week's SH HATOC to reaffirm it's approval of the route.

- Affirmation of Totnes Littlehempston All Access Path to DCC LCWIP list for capital schemes
- DCC Annual Waiting restrictions programme 2025/26 (none proposed in this division)

Devon Bus Forum 03.03.25

This group meets quarterly to discuss improvements to bus services, routes and access and uptake of use. This meeting covered the following topics:

- A further £10.3M has been received from Government to continue the work of the Bus Service
 Improvement Plans (BSIP). This is based on match funding. The capital spending on this will include capital
 spending on Zebra 2 electric buses due to start being rolled out in Exeter in June and there will also be an
 initiative use this also to help smaller operators to reduce their carbon footprint. The revenue elements are
 intended to;
 - o Improve highways access routes for buses to improve services
 - Better integration of smaller bus service operators and other services including trains and making timetables work well etc.
 - Supporting the flat price bus fare that has improved take up of services. This has been increased from £2 to £3 charge.
 - Bus users can (and are being encouraged to) report buses that fail to arrive or very late at this link:

Karen Rose is the officer leading on this work and I've mentioned to her that Inclusive Totnes might be a helpful contact to feed in views about facilities and services for all disabled persons.
- Bus Driver Disability Training. Devon County Council, partnered with Devon in Sight (The Devon County Association for the Blind), Living Options Devon and North Devon Voluntary Services to help smaller & medium sized commercial bus operators and Community bus schemes to design and deliver a first-rate Disability Awareness Training Programme. The Driver Disability Awareness Training recognised how critical the role of the bus driver is to a passenger's journey experience. Helping drivers to overcome their own concerns about offering help to passengers with protected characteristics such as disability. A manual is also available


SWW but does not anticipate them investigating further as they claim this is not connected to their supplies or services. I will update when more information is provided

Devon Authorities Strategic Waste Committee (DASWC) 11.02.25. The meeting was provided with an update on the Clean Devon Action Plan for 2025- 2027. This included

- Surveillance interventions to deter fly tipping and the logistical barriers to involvement from some districts (who were keen);
- Support for the Keep Britain Tidy Great British Spring Clean Campaign support. DASWC supports this
 campaign each year, but is widening the scope of its support, including using bus backs for advertising with a
 focus on litter from vehicles.
- How success would be recorded, including practical difficulties around metrics such as net tonnage, where reuse of materials would mean lower tonnage of materials recycled, which should not be recorded as a negative. Officers acknowledged the difficulties and advised that the key metric would be participation rates, determined by the data collected on bin usage by loading crews, with dedicated monitoring pre- and post-intervention;

- How data collection would be ensured, including incentivising loading crews to record the data;
- How the proposed segmentation model differed to the Acorn segmentation used for waste analysis. This
 was in line with advice received from the Waste and Recycling Advisor Project (WRAP);
- Vehicle littering (in laybys etc), with concern raised around lack of police effort / involvement. It was noted
 that Devon and Cornwall Police were regular attendees at Clean Devon meetings, and that enforcement of
 fines for things like littering was the responsibility of the relevant local authority. Reference was also made
 to Operation Snap, which encouraged members of the public to upload footage of people contravening road
 safety rules, and whether there were opportunities to ensure closer working with the police to support local
 authorities in enforcing rules around littering; and

I informed the meeting that SHDC has initiated a review into its waste collection services (further to my concerns about the number of recycling bins in and around the streets and the dilapidated state of many of these collection bins). In line with this, I requested that information is provided comparing costs etc of the use of Shared MRFs (Material Recovery Facilities) across the county with the current varied kerb recycling services provided. It is hoped that this information could inform the review and assist in the sharing of waste collection services that will go forward in the wake of the Local Government Reform current shake up.

BERNARD SUNLEY CHARITABLE FOUNDATION

Each year, the Bernard Sunley Charitable Foundation gives more than £4.5 million in grants to capital projects that support communities and provide facilities for those in need. Charities that are seeking funding for a capital project such as new build, major refurbishment or transport, can apply to the Foundation for a contribution towards the costs.

- Community village halls (especially in isolated rural areas), scout huts, youth clubs, community centres and sports facilities. Funding is also available to churches where the project will benefit the wider community.
- Education support for children and young adults from disadvantaged backgrounds or with special needs/disabilities. This can include the purchase of new minibuses for children with special needs and educational facilities at museums, galleries and arts organisations
- Health improvements to care homes, hospices, day centres or other facilities for the elderly and those with special needs; the creation or refurbishment of outdoor or recreational spaces for patients and specialist new transport.
- Social welfare residential and other facilities to support and improve the lives of vulnerable people
 including veterans, the elderly, those seeking help with addiction, homelessness, ex-offenders and victims of
 domestic and sexual abuse.

There are three levels of grants: Large - £25,000 and above; Medium - up to £20,000; and Small - £5,000 and under. Applications are accepted from registered charities, CIOs, specialist schools, scout and guide groups and housing associations. Co-operatives and Community Benefit Societies registered with the FCA can also apply.

Church of England: Boiler Replacement Hardship Fund

As part of the Church of England's Net Zero by 2030 programme, grants up to £45,000 are available to churches and church halls to cover the difference in cost between a low-carbon heating system and an oil or gas heating system. The Boiler Replacement Hardship Fund will help churches to reduce their carbon emissions. It aims to provide support to churches that most need it: where the existing heating system is failing; and where the church cannot afford to fund a low-carbon replacement in full.

The grant will cover the full difference in cost between the low carbon system and an oil/gas system where the difference is less than £25,000. If the difference is more than £25,000, deprivation data will be used to determine the level of grant that can be awarded. The maximum grant is £45,000.

The grants are for churches and church halls where activities are taking place in a building owned by part of the Church of England. The existing oil or gas boiler must be at end of life or have failed and need to be replaced urgently. You will need to have received professional advice about the proposed low-carbon solution and this needs to be supported by an energy audit or action plan.

The funding is for projects that can start before December 2025.

High Street Rental Auctions Fund

High Street Rental Auctions (HSRAs) are a new power for local authorities to require landlords to rent out persistently vacant commercial properties to new tenants such as local businesses or community groups. If a commercial high-street property has been vacant for 366 days or more in a 24-month period, a local authority can instigate a 'rental auction' to find a suitable tenant for the property.

To facilitate the process, the government is providing grants to help local authorities to:

Create a high-street commercial vacancy register:

Refurbish properties that are subject to a High Street Rental Auction to the required minimum standard It is anticipated that the cost of producing a vacancy register will be approximately £3,000 to £8,000; and the average refurbishment costs will be approximately £50,000 per property. Local authorities can also claim a new burdens payment of £5,223 to cover the cost of setting up the scheme eg. marketing, auction and legal costs incurred as a result of implementing the new powers.

The scheme is for local authorities with planning powers.

Application deadline:31 January 2026 (the fund may close sooner if all the funding is allocated)

Children's Alliance

Non-profit organisations including schools, registered charities, community interest companies and registered community groups can apply for grants to deliver water-based projects for disadvantaged children. The funding comes from the Children's Alliance which aims to get children into water safely to learn, develop and purposefully play for the benefit of their physical and mental wellbeing. Projects must support children under the age of 18 and clearly show the relationship to water or water environments within the project.

The Children's Alliance is interested in projects that address the following themes: Physical activity, mental health, environment, education, participation and diversity

The grants will usually be up to £15,000 with most grants awarded being under £10,000. Focus of fund/fund aims: Grants for projects to give children and young people a better start in life through the medium of water.
